- 14 identified corridors throughout the North Country
- Almost every single community is along a corridor

Vision for the Transportation Network

Vision Statements

- The North Country will be a destination for current residents, visitors, and those seeking new opportunities.
- Our communities will have thriving town centers and downtowns.
- Residents and visitors will have access to a variety of transportation and transit options to get around the region.
- The transportation network will be well-maintained and efficiently moves people and goods.

Goals & Objectives

- Meant to work to achieve the regional vision in the opening segments
- Goals are organized under 5 focus areas:
 - Safety
 - Accessibility
 - Environment
 - Economy
 - Collaboration





Safety

- Improve the Mobility, Safety, and Accessibility for all users and modes of travel.
- Preserve, Maintain, and Improve the Existing Transportation System.

Accessibility

- Create a transportation system that provides residents and visitors of all ages and abilities access to regional housing, employment, recreation, amenities, and services.
- Incorporate Accessibility requirements and considerations into regional projects and developments

Environment

- Conserve open space and traditional land uses.
- Connect Transportation Decisions with Land-Use Decisions.
- Protect the natural resources and the rural and wild natural environment of the region.

Economy

- Develop our town and village centers as destinations to live, work, and play.
- Create and Maintain a resilient regional economy.
- Encourage a mixture of housing types to meet the demand of all market sectors.

Collaboration

- Increase collaboration with partners and stakeholders at the local, regional, state, and federal levels to enhance transportation project planning and implementation outcomes.
- Includes holding regular meetings of boards and commissions, develop working relationships with a variety of groups, and conducting outreach to new groups.

Corridor Datasheets

The Corridor Datasheets contain helpful information such as:

- Census Information
- Assets (attractions, historic areas, infrastructure, etc.)
- Major connections with other routes and regions
- Traffic volumes at important junctions
- Maps
- Important Current and Identified Projects



Regional Transportation Improvement Program (RTIP)

- The RTIP is updated every two years, and coincides with the State Ten-Year Plan process
- The RTIP for State Fiscal Years (FY) 2025-2034 consists of regionally significant programmed and proposed transportation projects for the North Country Council planning region.
- Projects on the RTIP have been programmed through the Ten-Year Plan and other state and federal funding sources
